1 Digital Signature Validation

After receiving digitally approved Licence certificate from *pareshram portal* with “Validity unknown” as indicated (Refer to Figure 1), Kindly follow the following steps for getting a valid digitally signed certificate.

- Right click on the signature portion then click on *signature properties* (Refer to Figure 2).








Figure 4 – Certificate Details




Figure 5 – Add to Trusted Certificates




Figure 6 – Confirm Revalidation




Figure 7 – Select Certified Documents
