The scrutiny officer does preliminary assessment of the application and puts up file to the approving authority with his comments proposing a field verification report from concerned Divisional Deputy Director of Factories and Boilers/ Zonal Asst. Director of Factories and Boilers about suitability of the firm for grant of certificate for recognition as Boiler Manufacturer. After approval by Approving Authority the letter is issued to respective field officers calling for field verification in time bound manner.

On receipt of field verification report, the receiving official again puts up the file to designated scrutiny officer. The scrutiny officer evaluates the application afresh in view of inputs in field verification report & submits the file to the approving authority with his comments if any.

The approving authority approves or rejects the application based on merit and suitability on case to case basis and decision is communicated to the applicant.

After approval, certificate for recognition as Boiler Manufacturer is issued to the applicant in prescribed proforma.
